ORDER

On April 6, 2001, the plaintiff filed an Application to Clerk for Entry of Default as to the defendant, SportsMed Products, Inc.; and on April 17, 2001, the Court entered a default judgment in favor of the plaintiff and against said defendant, with leave to prove damages in connection therewith.

On April 11, 2001, the plaintiff filed a Motion for Judgment by Default against the defendant, SportsMed Products, Inc., with attached Affidavit of Memory Williamson, the Senior Vice President of First Bank of Childersburg, a copy of the Note dated November 5, 1996, and the Affidavit of Rachel J. Moore.

After due consideration thereof, said Motion for Judgment by Default is **GRANTED**; and **DEFAULT JUDGMENT** is hereby entered in favor of the plaintiff and against the defendant, **SPORTSMED PRODUCTS, INC.**, for the sum of THREE HUNDRED EIGHTEEN THOUSAND TWO HUNDRED SEVEN AND 14/100 (\$318,207.14) DOLLARS, which sum consists of \$246,819.76 principal; \$22,023.42 interest; and \$49,363.96 attorney's fee.

This case remains on the plaintiff's claim against the defendants Law Lamar, IV and Hugh Morrow.
