DEFAULT JUDGMENT

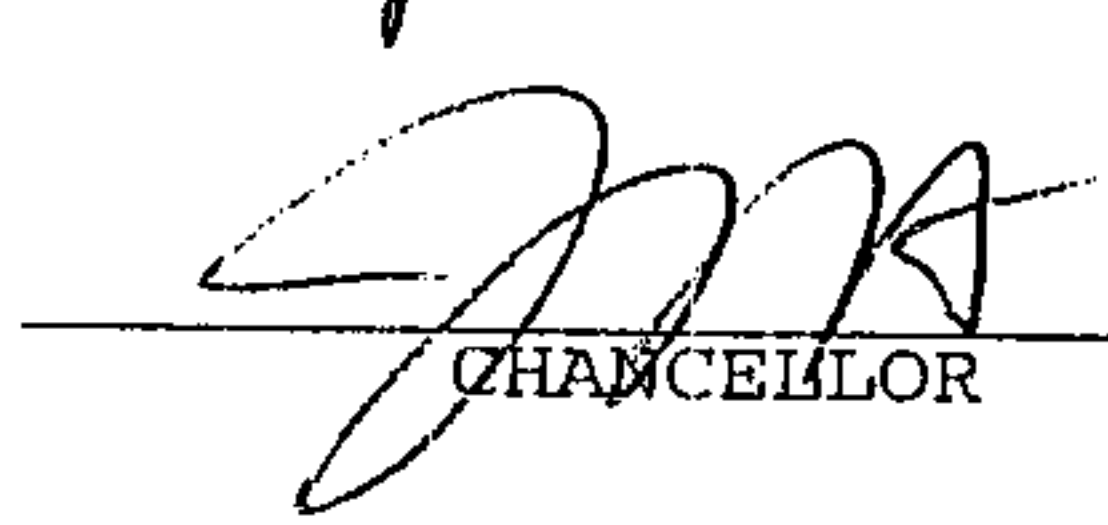
Plaintiff's motion for default judgment came to be heard by the Court on Tuesday, September 19, 2000. The Court record shows that Defendant Promek, Inc. was served with process on July 31, 2000 and Defendant Rick W. Guider was served with process on August 8, 2000. The record further shows that neither Promek, Inc. nor Rick W. Guider has answered or otherwise appeared in this action.

After reviewing the record, including the affidavit of debt submitted by Mark Davis, Plaintiff's District Credit Manager, the Court finds that Defendants are indebted to Plaintiff in the principal amount of \$431,324.99. The Court further finds that Defendants are liable to Plaintiff for interest in the amount of \$57,101.85. The Court further finds that Defendants are liable to Plaintiff for contractual attorneys' fees in the amount of \$2000⁰⁰.

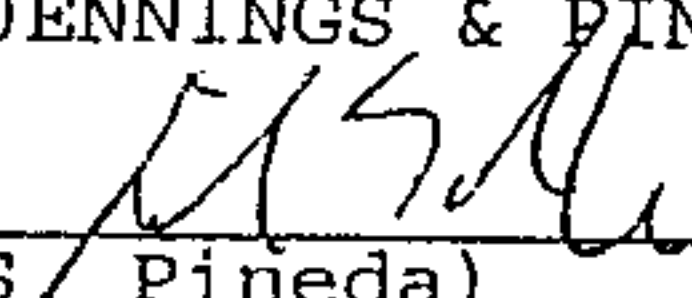
Wherefore, the Court hereby grants Plaintiff Hajoca Corporation a judgment against Promek, Inc. and Rick W. Guider, jointly and severally, in the total amount of \$490,426⁸⁴.
