## LOAN MODIFICATION AGREEMENT (Providing for Fixed Interest Rate)

This Loan Modification Agreement ("Agreement"), made effective the 31st Day of August, 2000 between Johnnie G. Cunningham, Jr. ("Borrower") and Chase Manhattan Mortgage Corporation ("Lender"), amends and supplements (1) the Mortgage, Deed of Trust or Deed to Secure Debt (the "Security Instrument") to American Investment Mortgage, Inc., dated October 2, 1997, recorded October 10, 1997, as Instrument No.1997 33123; and subsequently assigned to Chase Manhattan Mortgage Corporation, by assignment recorded December 18, 1997, as Instrument No. 1997-41090, County of Shelby, State of Alabama (2) the Note bearing the same date as, and secured by, the Security Instrument ("Note"), (collectively, the "Loan Documents"), which cover the real and personal property described in the Security Instrument and defined therein as the "Property", located at 1864 21st Avenue, Calera, Alabama 35040, with the original principal balance of U.S. \$55,726.00, the real property described being set forth as follows:

LOT 1, BLOCK 264, ACCORDING TO THE PLAT OF RESURVEY OF LOTS 1,2,3,4,6,7,8 & 9, IN BLOCK 264; AND LOTS 5,6,7,8,9,11 & 12, IN BLOCK 253, MAP BOOK 3, PAGE 123, IN THE PROBATE OFFICE OF SHELBY COUNTY, ALABAMA; BEING SITUATED IN SHELBY COUNTY, ALABAMA.

In consideration of the mutual promises and agreements exchanged, the parties hereto agree as follows (notwithstanding anything to the contrary contained in the Loan Documents):

- 1. As of September 1, 2000, the amount payable under the Loan Documents is U.S. \$65,922.01 (the "Unpaid Principal Balance") consisting of the amount(s) loaned to the Borrower by the Lender and any interest capitalized to date.
- 2. The Maturity Date of the above referenced Note has been amended from October 1, 2027, to September 1, 2030 ("Maturity Date").
- 3. The Borrower promises to pay the Unpaid Principal Balance, plus interest, to the order of the Lender. Interest will be charged on the Unpaid Principal Balance at yearly rates as specified below:
  - (a) The rate of 8.5% for the payments due from October 1, 2000 through and including September 1, 2030.
- 4. The Borrower promises to pay the Unpaid Principal Balance, plus interest, to the order of the Lender. The Borrower promises to make monthly payments of principal and interest as specified below:
  - (a) Monthly payments of \$506.88 for the payments due from October 1, 2000 through and including September 1, 2030. If on the Maturity Date, the Borrower still owes amounts under the Loan Documents as amended by this Agreement, the Borrower will pay such amounts in full on the Maturity Date.

The Borrower will make such payments at P.O. Box 78109 Phoenix, AZ 85062-8109, or at such other place as the Lender may require.

5. If all or any part of the Property or any interest in it is sold or transferred (or if a beneficial interest in the Borrower is sold or transferred and the Borrower is not a natural person) without the Lender's prior written consent, the Lender may, at its option, require immediate payment in full of all sums secured by the Loan Documents. If the Lender exercises this option, the Lender shall give the Borrower notice of acceleration. The notice shall provide a period of not less than 30 days from the date the notice is delivered or mailed within which the Borrower must pay all sums secured by the Loan Documents. If the Borrower fails to pay these sums prior to the expiration of this period, the Lender may invoke any remedies permitted by the Loan Documents without further notice or demand on the Borrower.

  - all terms and provisions of any adjustable rate rider or other instrument or (b) document that is affected to, wholly or partially ir corporated into, or is part of, the Loan Documents and that contains any such terms and provisions as those referred to in (a) above.
- Nothing in this Agreement shall be understood or construed to be a satisfaction or release in whole or in part of the Loan Documents. Except as otherwise specifically
