

**THIS AMENDMENT TO MORTGAGE SECURES ADDITIONAL
INDEBTEDNESS OF \$250,000.**

FIRST AMENDMENT TO MORTGAGE

This First Amendment to Mortgage entered into this 6th day of June, 2001, by Shelby Springs Stock Farm, Inc. (the "Mortgagor") in favor of National Bank of Commerce of Birmingham (the "Bank").

RECITALS

A. By Real Estate Mortgage dated September 8, 1998 and recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst. #1998-35754, the Mortgagor granted a mortgage (the "Mortgage") to the Bank to secure indebtedness in the principal amount of \$1,425,000.00 (the "Loan"), which Loan has a current outstanding principal balance of \$912,838.45.

B. The Mortgagor has requested the Bank to amend the Loan by extending additional credit to the Mortgagor, which amended Loan shall be evidenced by that Master Note – Commercial Loans dated June 6, 2001 in the original amount of \$1,162,838.45. The Bank has agreed to extend further credit to the Mortgagor upon the conditions, among others, that the Mortgage execute and deliver this "First Amendment to Mortgage" in order to increase the amount of debt secured by the Mortgagor and to take additional real property to secure the Loan.

AGREEMENT

1. The Mortgage is hereby amended by replacing the second Paragraph of the Mortgage in its entirety with the following:

Whereas, Shelby Springs Stock Farm, Inc. is justly indebted to the Mortgagee in the amount of One Million One Hundred Sixty-Two Thousand Eight Hundred Thirty-Eight Dollars and 45/100----(\$1,162,838.45) as evidenced by that certain promissory noted dated June 6, 2001, which bears interest as provided therein.

2. In order to add additional property to this Mortgage, Exhibit "A" of the Mortgage is hereby replaced in its entirety with Revised Exhibit "A" attached hereto.

3. Except as herein modified, the Mortgage shall remain in full force and effect.


