EASEMENT

Roger D. Rader and Linda C. Rader ("Grantor") hereby grant and convey to MARCUS CABLE OF ALABAMA, L.L.C. ("Grantee") its successors and assigns, a dedicated, perpetual non-exclusive easement over and across that real property described below as the "Easement" for roadway and communication purposes, including the installation, construction, maintenance, operation, removal and repair of Grantee's (or its licensee's) broadband cable communications system facilities and any other related communications facilities, (specifically limited to underground or above ground pole-mounted fiber optic cables, related cables, conduit, nodes, and transmission equipment for the transmission, and distribution of video programming, audio/data communications, and/or Internet access signals), facilities attributable to any utilities necessary for the Grantee's broadband cable communications operations, general access, ingress and egress (including roadway construction).

- EASEMENT: The property over/through which the Easement is granted is hereinafter called the "Easement" and is described in Exhibit A attached hereto as "Easement A".
- EASEMENT APPURTENANT: This Easement is appurtenant to the property described in Exhibit A and shall run with the land.
- <u>CONSIDERATION</u>: Grantee shall pay to Grantor a one-time 3. payment of \$1,000.00 in consideration for the grant of the rights herein by Grantor to Grantee for said dedicated, perpetual, non-exclusive easement, within thirty (30) days of the execution hereof.
- MAINTENANCE: Grantor and Grantee shall be equally 4. responsible for the cost associated with the maintenance of Easement "A" as the easement affects the current roadway known as Woods Drive. This agreement shall run with the land.

5. EXISTING FACILITIES: Grantee has 60 days from the execution date of this Easement Agreement to remove all existing structures and equipment not specifically allowed under this agreement from the Easement Area, except as may be permitted under a separate lease agreement between the Grantor and Grantee.
