the undersigned hereby adopts the following Articles of Incorporation.

ARTICLE I The name of the Corporation is G S MASTERS, INC.

articles are filed.

ARTICLE III The corporation has been organized for the following purpose(s):

as permitted by Alabama Business Corporation Law.

ARTICLE IV The corporation shall have the authority to issue one thousand (1000)


