KNOW ALL MEN BY THESE PRESENTS, that in consideration of ONE HUNDRED SIXTY THREE THOUSAND AND NO/100 (\$163000.00) DOLLARS and other valuable considerations to the undersigned GRANTOR or GRANTORS in hand paid by the GRANTEE(S) herein, the receipt whereof, is hereby acknowledged I/we, **JEFFREY J. POPOVNAK and ANDREA J. 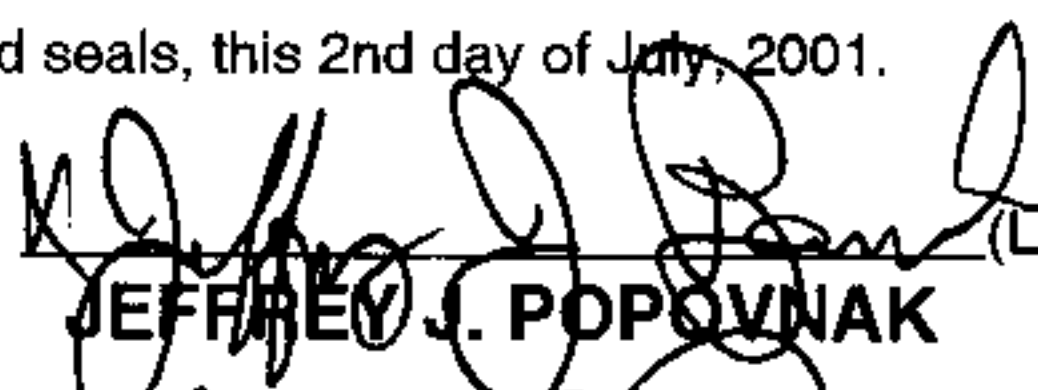
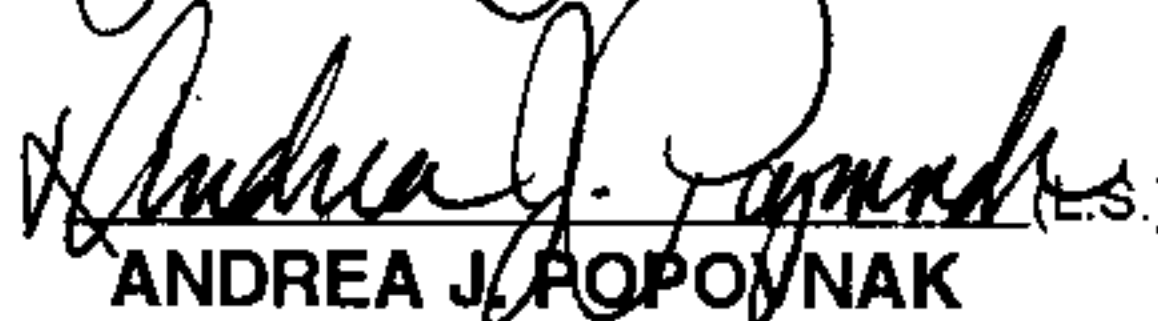

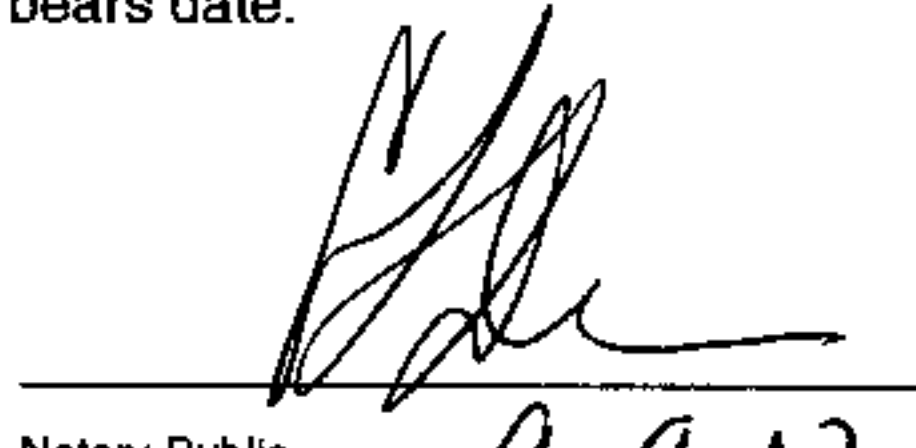
