Know All Men by These Presents: That in consideration of **One hundred forty four thousand five hundred and no/100 (\$144,500.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Carolyn J.
