AFFIDAVIT OF PEGGY SEAY EADY

Before me, the undersigned notary public, in and for said County, in said State, personally appeared Peggy Seay Eady, and after being duly sworn, under oath by me, deposes and states as follows:

1. My name is Peggy Seay Eady. I am over the age of 21 years. I have personal knowledge of the information contained herein.
2. My residence is 5615 Hunter Brook Court, Gardendale, Alabama 35071
3. Currently I am retired.
4. I am the executor of the William Berkley Seay Estate (my father). I am an heir to this estate which includes a forty acre tract of land. There are 14 additional heirs to this forty acre parcel of land in this estate. The land is described as the NE1/4 of the SW1/4 of Section 14, T19S, R1E, being 40 acres more or less. I am issuing this statement to make known that four (4) of the heirs are deceased. They are listed below:

William B. Seay Jr., died in 1964, in Birmingham, Alabama, testate (with a will), and left all possessions to Bernadine Seay Rich, his surviving wife, his five children - Martha Seay Miller, Paula Seay Cunningham Hessler, William B. Seay III, John L. Seay and William J. Seay.

William B. Seay III, died in 1986, in Birmingham, Alabama, testate (with a will), and left all possessions to Karen Seay Ammons (his wife) and William B. Seay IV (his only child).

Elizabeth S. Weir, died on March, 25 1997, in Birmingham, Alabama, testate (with a will), and left all possessions to Billie W. Morris and Peggy W. Rawls (her two Daughters & only children). Her husband died in November 28, 1995.

James A. Seay, died on August 5, 1982, in Houston Texas, in testate (without a will). His heirs were his wife and three (3) children. They are Janice H. Seay (wife), James D. Seay (son), Michael F. Seay (son), and Judi Seay Tobin (daughter). His wife was living at the time of his death.

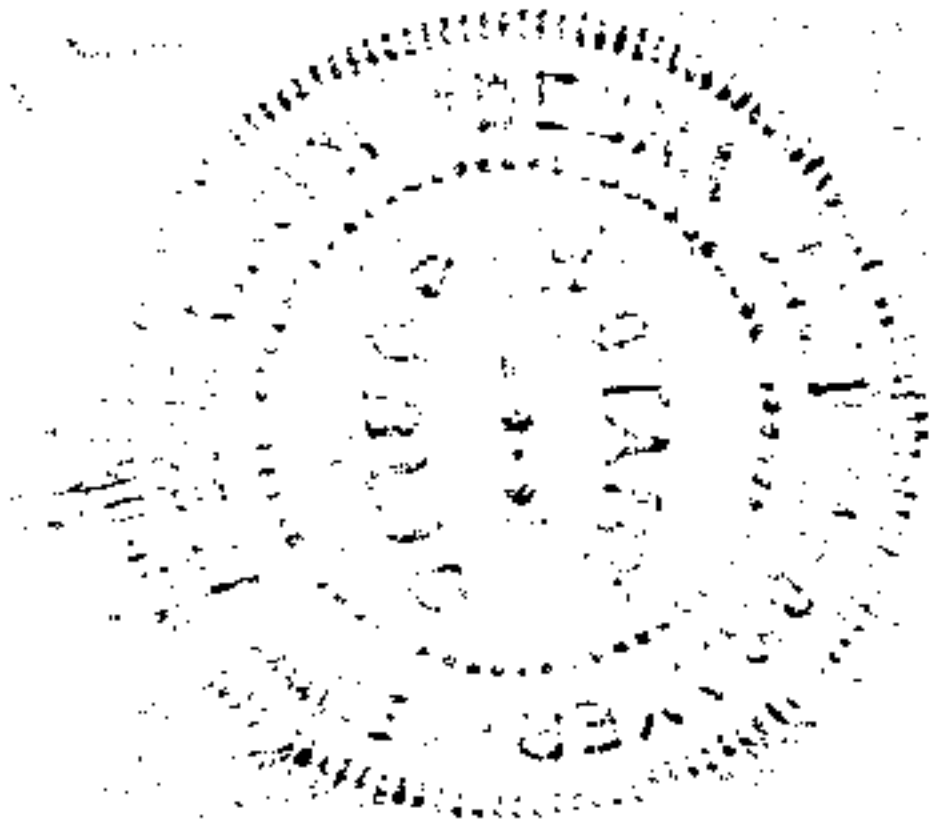
