## GENERAL AND DURABLE POWER OF ATTORNEY

- 5. Sign, seal, execute, acknowledge and deliver such deeds, leases and assignment of leases, agreements, mortgages, releases and satisfaction of mortgages and such other instruments in writing or whatever kind and nature as may be necessary or proper in the premises.
