**POWER OF ATTORNEY FOR THE PURPOSE OF

PURSUANT TO CODE OF ALABAMA, SECTION 26-2A-7**

The said **JEFFERY LYNN LINDSEY** and **MELISSA LYNN LINDSEY** are hereby empowered to sign as my attorney in fact any reasonable documentation necessary for the pursuance of the powers herein granted, and is further empowered to prosecute to conclusion any and all actions which hereafter may be undertaken in regard to the health, support, education and/or maintenance of said minor child and they are hereby empowered to retain and employ any and all attorneys, agents, or other professionals which they may deem necessary and proper to appear and plead before any Court having any jurisdiction arising pursuant to the powers granted herein.

This Power of Attorney shall remain in full force and effect until written revocation is presented to the grantees by the grantor.
