ARTICLES OF INCORPORATION

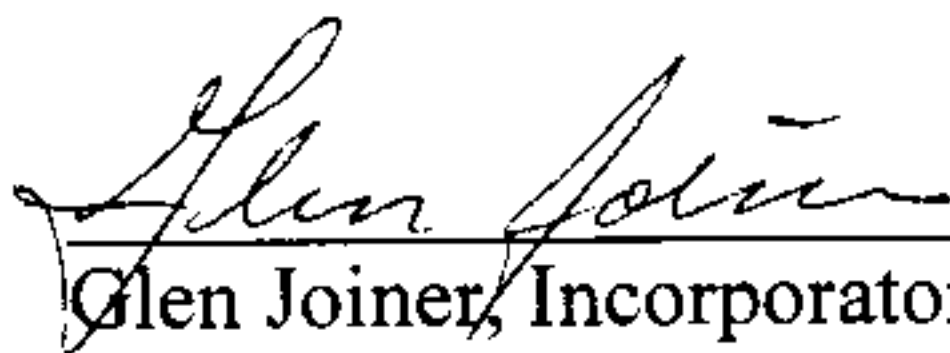

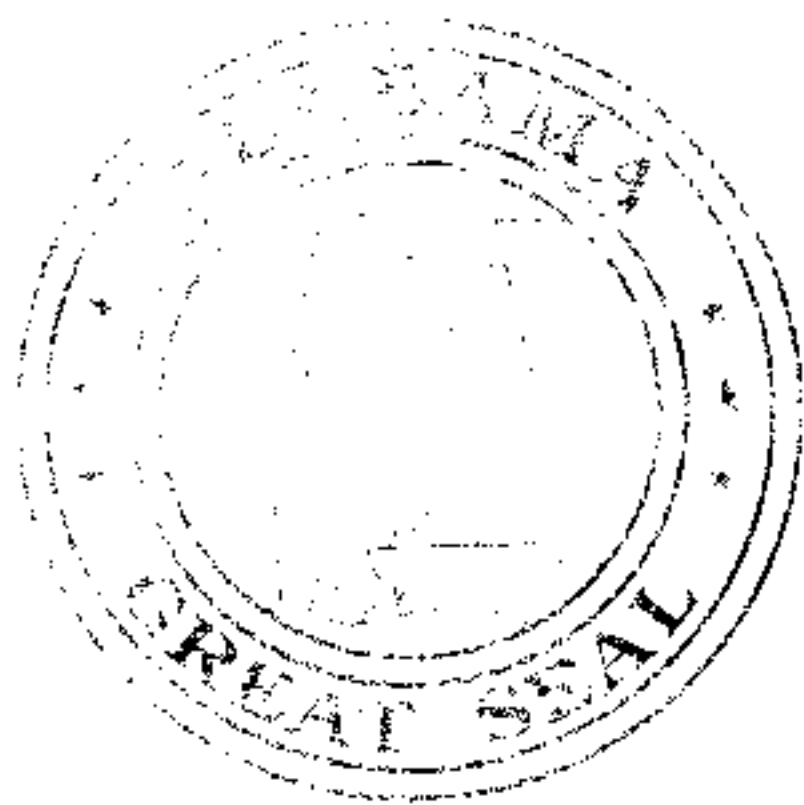
