KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of Two Hundred Ninety Thousand Four Hundred and 00/100 (\$290,400.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS, **Roger L. Alexander and Betty T. Alexander, husband and wife** (hereinafter referred to as GRANTORS), the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEES, **Joseph Freeman Jolly and Rose Marie Jolly, husband and wife**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of SHELBY, State of Alabama, to-wit:

Lot 507-A, according to a Resurvey, as recorded in Map Book 19, page 98, in the Probate Office of Shelby County, Alabama, of Lots 506-510, Eagle Point, 5th Sector.


Subject to existing easements, current taxes, restrictions and covenants, set-back lines and rights of way, if any, of record.

\$232,320.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.


