Described property to become the homestead of Grantees.

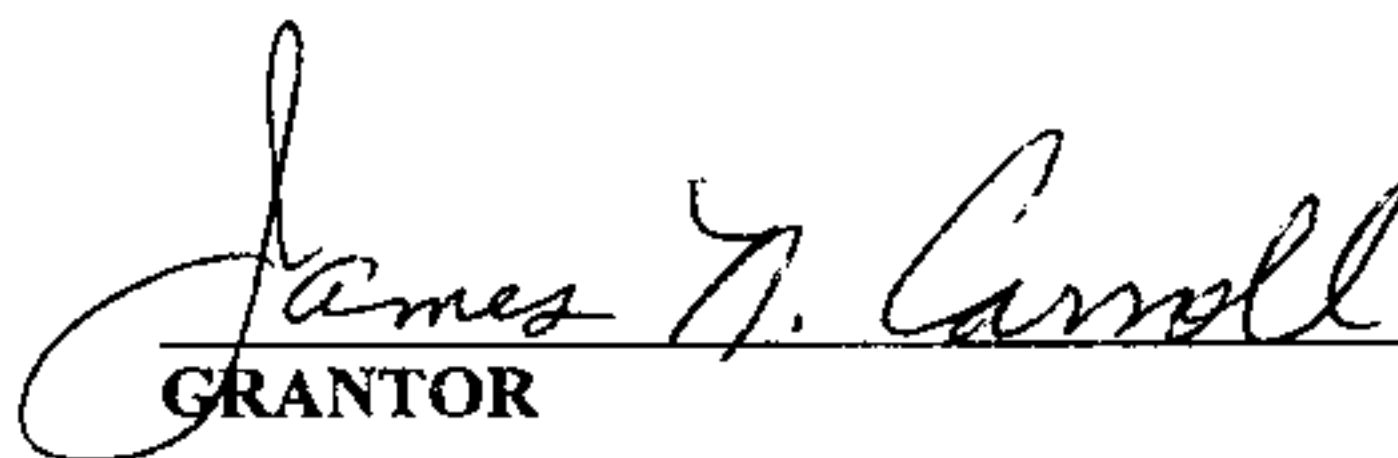

claims of all persons.

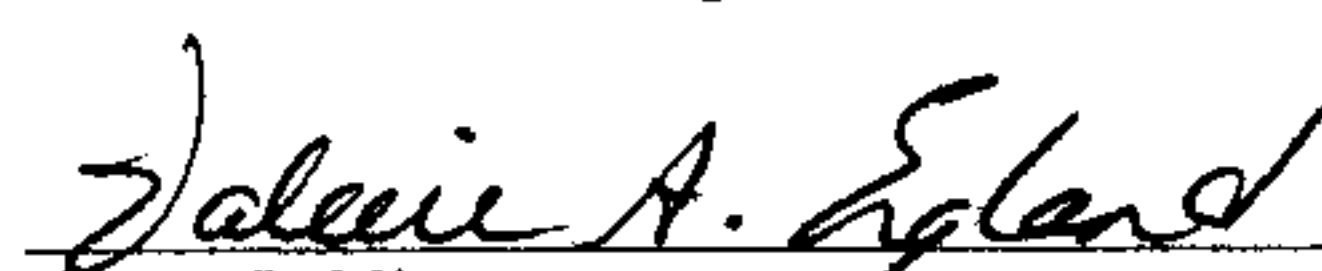
