

**ARTICLES OF INCORPORATION
OF
SEARCH FOR THE MISSING CHILDREN FOUNDATION, INC.**

Pursuant to the provisions of the Alabama Non-Profit Corporation Act, the undersigned hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation is: Search For The Missing Children Foundation

ARTICLE II

The duration of the corporation is perpetual.

ARTICLE III

The corporation has been organized for non-profit and may engage in any lawful business for which a corporation may be organized in the state of Alabama. The initial purpose of the foundation is to place images of missing children on racecars to assist the families in obtaining national exposure and to help the authorities with additional leads in finding a missing child.

ARTICLE IV

The corporation is authorized to issue only one class of shares of stock which shall be designated Common Stock, \$1.00 par value; and the total number of shares which this corporation is authorized to issue is 10,000. No shares have been issued.


The liability of the directors of this corporation for monetary damages shall be eliminated to the fullest extent permissible under Alabama law.

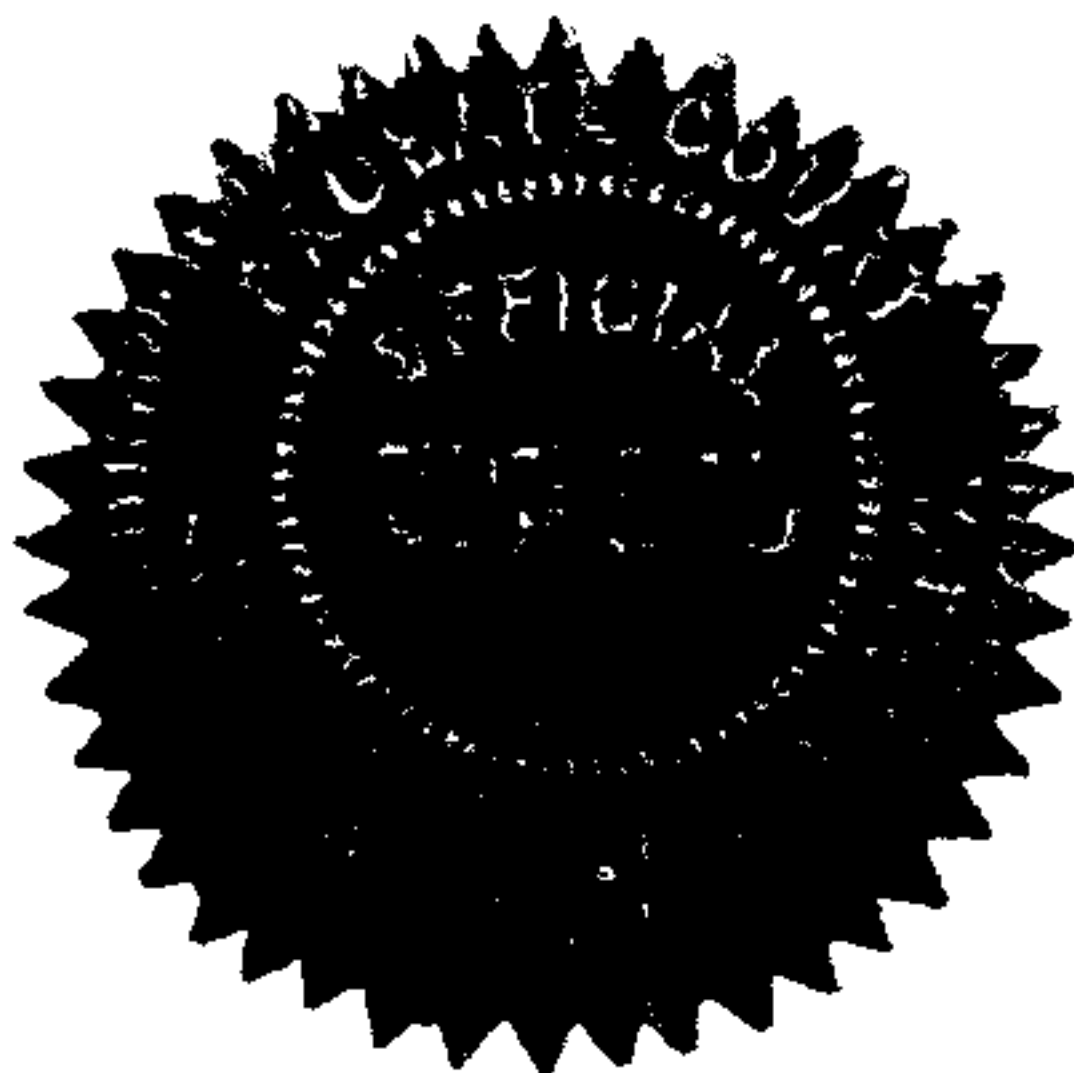
