Know All Men by These Presents: That in consideration of **One hundred fifty three thousand and no/100 (\$153,000.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **James G. Terrell and Alberta L. Terrell, husband and wife** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Christopher M. Douglas and Brenda L. Douglas** (herein referred to as grantee, whether one or more), the following described real estate, situated in **Shelby County, Alabama, to-wit:**
