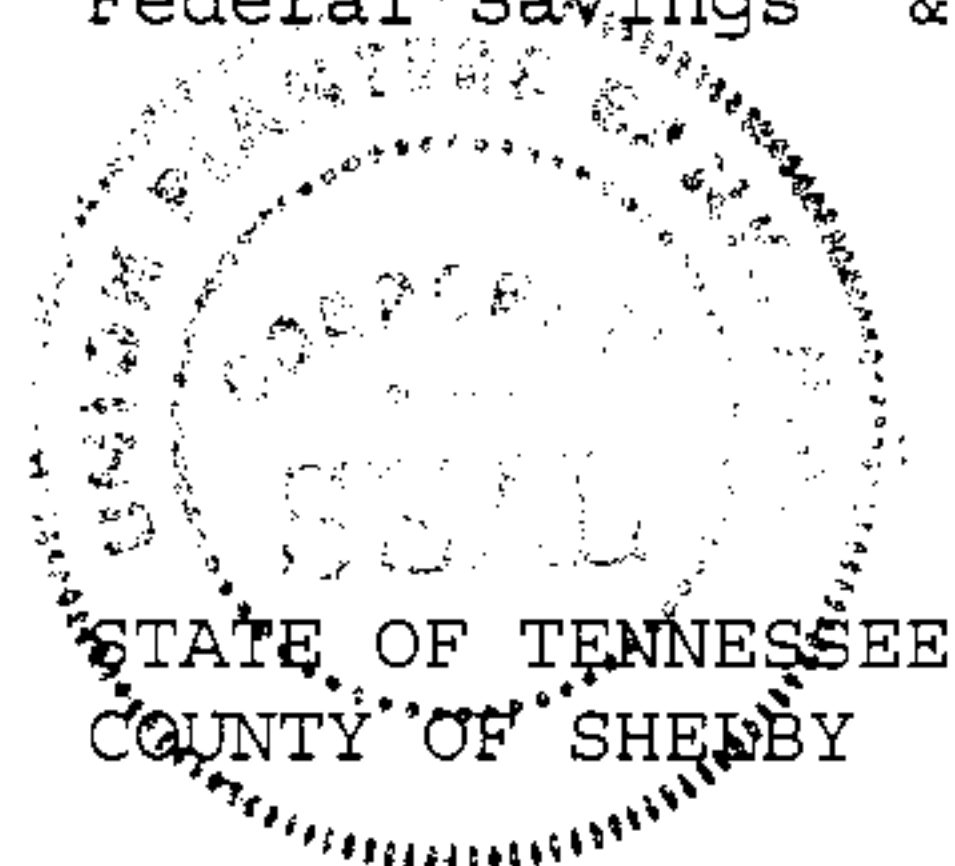
KNOW ALL MEN BY THESE PRESENTS, CAROLYN A WAILES

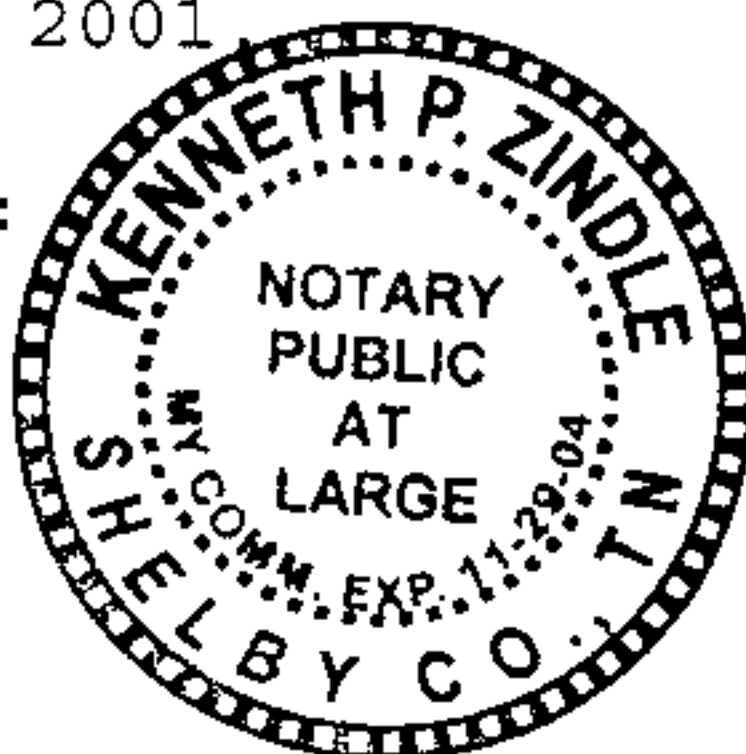
