West (magnetic Bearing) along Section line a distance of 1311.26 feet to a point (being NW corner of SW 1/4 of SW 1/4 of said Section 24); thence North 85 deg. 28 min. East (MB) along 1/4 - 1/4 line a distance of 1337.0 feet to a point (being NE corner of SW 1/4 of SW 1/4 of said Section 24); thence South 2 deg. 06 min. 30 sec.
