KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of Two Hundred Ten Thousand and No/100 Dollars (\$210,000.00) the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged **TAMBRIDGE BUILDING CO., INC.**, (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto **ROBERT JOSEPH WARD, JR. & LAUREN SOPHIA HILL**, (herein referred to as "Grantee"), as joint tenants with rights of survivorship, the following described real estate situated in Shelby County, Alabama, to wit:

Lot 311, according to the Survey of Lake Forest, Third Sector, as recorded in Map Book 26, Page 143, in the Probate Office of Shelby County, Alabama.


