KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of Fifty-Nine Thousand and 00/100 Dollars (\$52,000.00) to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged, **P & R SOUTHLAND PROPERTIES, INC** (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto **CURTIS W. POSEY & HILDA B. POSEY**, (herein referred to as "Grantee") as joint tenants with rights of survivorship, the following described real estate situated in Shelby County, Alabama, to wit:


Subject to all easements, restrictions, covenants, rights of way and covenants of record; taxes for 2001 subsequent years not yet due and payable.


