KNOW ALL MEN BY THESE PRESENTS:

That in consideration of **FIVE HUNDRED FOURTEEN THOUSAND THREE HUNDRED FIFTEEN AND 20/100 (\$514,315.20) DOLLARS** and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, I or we, **Page H. Seier, a widow, and George F. Seier, Jr., as Trustee of the "Family Trust" as established under the will of George F. Seier, Sr., deceased, Probate Docket 33, page 138, in the Probate Office of Shelby County, Alabama** (herein referred to as grantors) do grant, bargain, sell and convey unto **Bobby Ray Ellison** (herein referred to as grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:
