GENERAL DURABLE POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS: That I, DAVID BENJAMIN ROSENBLUM (SS# (dob 01/29/44), of the County of Shelby, State of Alabama, have made, constituted and appointed, and by these presents do make, constitute and appoint my cousin, EUGENE N. HARRIS, of Marion, Alabama, to act as my true and lawful Attorney-in-Fact and Agent (hereinafter called "Agent"), for me in my name, place and stead, and for my behalf and benefit:

- 1. General Grant of Power: To exercise or perform any act, power, duty, right or obligation whatsoever that I now have or may hereafter acquire, relating to any person, matter, transaction or property, real (including my residence and homestead property) or personal, tangible or intangible, now owned or hereafter acquired by me, including, without limitation, the following specifically enumerated powers. I grant to my Agent full power and authority to do everything necessary in exercising any of the powers herein granted as fully as I might or could do if personally present, with full power of substitution or revocation, hereby ratifying and confirming all that my Agent shall lawfully do or cause to be done by virtue of this Power of Attorney and the powers herein granted:
- (a) Powers of Collection and Payment: To forgive, request, demand, sue for, recover, collect, receive, and hold all such sums of money, debts, dues, commercial paper, checks, drafts, accounts, deposits, legacies, bequests, devises, notes, interests, stock certificates, bonds, dividends, certificates of deposit, annuities, pension, profit sharing, retirement, social security, insurance and other contractual benefits and proceeds, all documents of title, all property, real or personal, intangible and tangible property and property rights and demands whatsoever, liquidated or unliquidated, now or hereafter owned by, or due, owing, payable or belonging to me or in which I have or may hereafter acquire an interest; to have, use, and take all lawful means and equitable and legal remedies and proceedings in my name for the collection and recovery thereof, and to adjust, sell, compromise, and agree for the same, and to execute and deliver for me, on my behalf, and in my name, all endorsements, releases, receipts, or other sufficient discharges for the same;
- (b) Power to Acquire and Sell: To acquire, purchase, exchange and grant options to sell, mortgage, pledge, lease, sell, give, and convey real (including my residence and homestead property) or personal property, tangible or intangible, or interests therein, on such terms and conditions as my Agent shall deem proper, with full authority to sign, endorse, execute and deliver any sales agreement, deed, bill of sale and all other instruments or documents pertaining to

the sale of any of my real (including my residence and homestead property) or personal property that I now own or am become entitled to after the execution of this instrument; and to enter into bonds, contracts, mortgages and deeds connected therewith;

- (c) Management Powers: To maintain, repair, improve, invest, manage, insure, rent, lease, encumber, and in any manner deal with any real or personal property, tangible or intangible, or any interest therein, that I now own or may hereafter acquire in my name and for my benefit, upon such terms and conditions as my Agent shall deem proper;
- (d) Banking Powers: To make, receive and endorse checks and drafts, deposit and withdraw funds, acquire and redeem certificates of deposit, in banks, savings and loan associations and other institutions, execute or release such deeds of trust or other security agreements as may be necessary or proper in the exercise of the rights and powers herein granted;
- (e) Motor Vehicles: To apply for a Certificate of Title upon, and endorse and transfer title thereto, for any automobile or other vehicle, and to represent in such transfer assignment that the title to said vehicle is free and clear of all liens and encumbrances except those specifically set forth in such transfer assignment;
- (f) Tax Powers: To prepare, sign and file income tax returns or declarations of estimated tax for any year or years; to prepare, sign and file gift tax returns with respect to gifts made by me for any year or years; to consent to any gift and to utilize any other tax election; and to prepare, sign and file any claims for refund of any tax;
- (g) Securities Powers: To acquire, purchase, exchange and to sell, pledge, convey any interest in any stocks, bonds or other securities I may now own or later become entitled to, with full authority to sign, endorse, execute and deliver, in my name, any such securities as my Agent shall deem proper;
- (h) Power to Hold Property and Make Investments: The power to hold or acquire any property or securities, regardless of whether such property or securities are so-called "legal" investments, where such course is, in my Agent's opinion, for my best interest;
- (i) Health Powers: To purchase or obtain items necessary for my health, support and maintenance, and to determine the care and custody and control of my person if I become unable to care for myself;
- (j) Miscellaneous Powers: To appoint agents or attorneys to assist in the transaction of any matters herein authorized; to carry out any other business matters on my behalf; and to do all things necessary or proper in connection with the above-authorized powers herein granted.
- 2. Interpretation and Governing Law: This instrument is to be construed and interpreted as a general durable power of attorney and is not to be affected upon my disability, incompetency or incapacity. The enumeration of specific powers herein is not intended to, nor does it, limit or

restrict the general powers herein granted to my Agent. This instrument is executed and delivered in the State of Alabama and the laws of the State of Alabama shall govern its provisions.

- 3. Third Party Reliance: Third parties may rely upon the representation of my Agent as to all matters relating to any powers granted to my Agent, and no person who may act in reliance upon the representations of my Agent or the authority granted to my Agent shall incur any liability to me or my estate as a result of permitting my Agent to exercise any power.
- 4. If my Agent cannot serve hereunder because of death, incapacity, or resignation, then I hereby appoint my Agent's son, Joseph Scott Harris, of Montgomery, Alabama, to serve with full power as herein given.
- 5. Revocation: This Power of Attorney may be revoked by a written revocation signed by me and filed in the Probate Office of Shelby County, Alabama, or by operation of law of the State of Alabama.

IN WITNESS WHEREOF, I have executed this General Durable Power of Attorney, and I have directed that photographic copies of this power be made, which shall have the same force and effect as an original.
