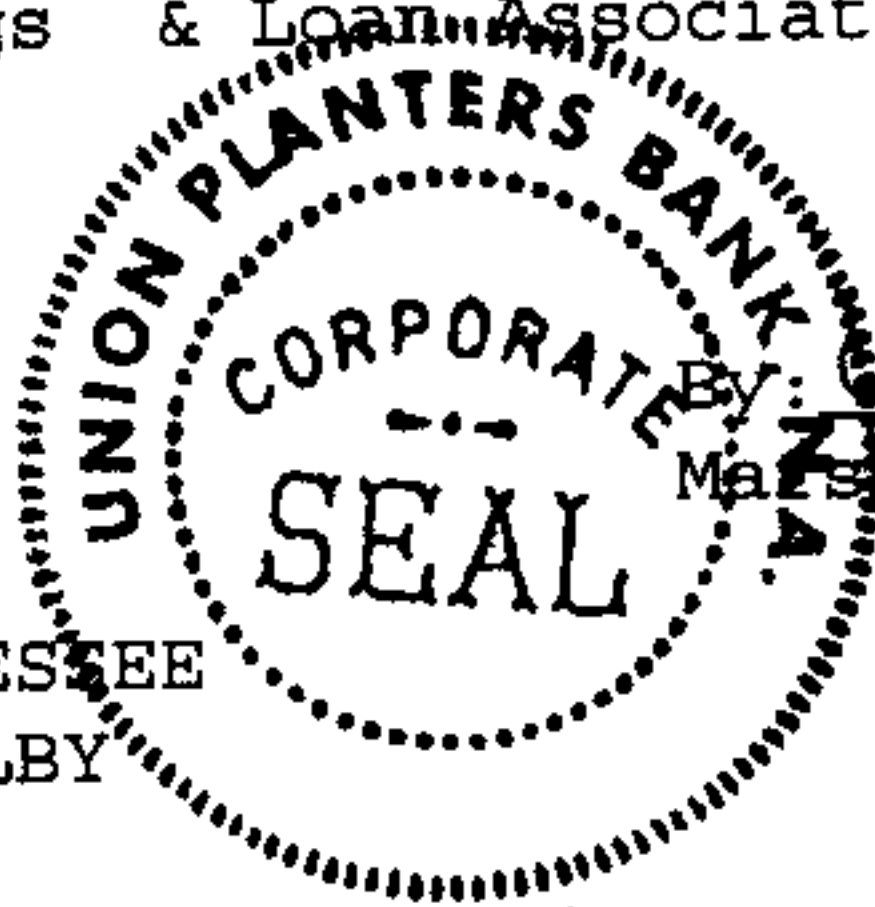
KNOW ALL MEN BY THESE PRESENTS, RALPH C. FULTON, JR. AND WANDA H. FULTON

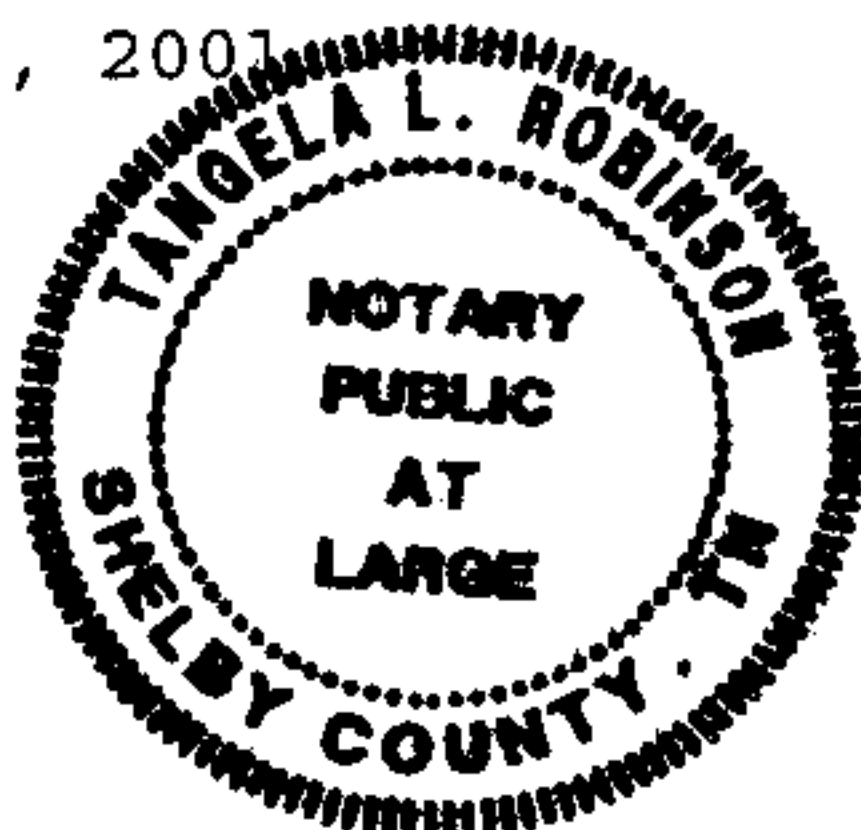
