1. That said Custom Steel Services, Inc., claims a lien upon the following property situated in Shelby County, Alabama, to-wit:

Parcel 1 - Cement Silo: Commence at the NE corner of the NE quarter - SE quarter - Section 24, Township 22 South, Range 3 West; thence run South along the east quarter - quarter line for a distance of 821.37 feet; thence deflect an angle of 90 degrees right for a distance of 264.70 feet to a point of beginning; thence deflect an angle of 109 degrees 39 minutes 51 seconds left and run southeasterly for a distance of 80.00 feet; thence deflect an angle of 90 degrees right and run southwesterly for a distance of 80.00 feet; thence deflect an angel of 90 degrees right and run northwesterly for a distance of 80.00 feet; thence deflect an angel of 90 degrees right and run northeasterly for a distance of 80.00 feet to the point of beginning, containing 0.15 acres, more or less.

Parcel 2 - Clinker Silo: Commence at the NE corner of the NE quarter - SE quarter - Section 24, Township 22 South, Range 3 West; thence run south along the east quarter - quarter line for a distance of 211.69 feet; thence deflect an angle of 90 degrees right for a distance of 399.82 feet to a point of beginning; thence deflect an angle of 84 degrees 52 minutes 16 seconds left and run southwesterly for a distance of 145.00 feet; thence deflect an angle of 90 degrees right and run northwesterly for a distance of 104.00 feet; thence deflect an angle of 90 degrees right and run northeasterly for a distance of 145.00 feet; thence deflect an angle of 90 degrees right and run southeasterly for a distance of 104.00 feet to the point of beginning, containing 0.35 acres, more or less.

Parcel 3 - Finish Mill Building: Commence at the NE corner of the NE quarter - SE quarter - Section 24, Township 22 South, Range 3 West; thence run south along the east quarter - quarter line for a distance of 479.01 feet; thence deflect an angle of 90 degrees right for a distance of 411.88 feet to a point of beginning; thence deflect an angle of 84 degrees 52 minutes 16 seconds left and run southwesterly for a distance of 114.00 feet; thence deflect an angle of 90 degrees right and run northwesterly for a distance of 110.00 feet; thence deflect an angle of 90 degrees right and run northeasterly for a distance of 114.00 feet; thence deflect an angle of 90 degrees right and run southeasterly for a distance of 110.00 feet to the point of beginning, containing 0.29 acres, more or less.




