Subject To:

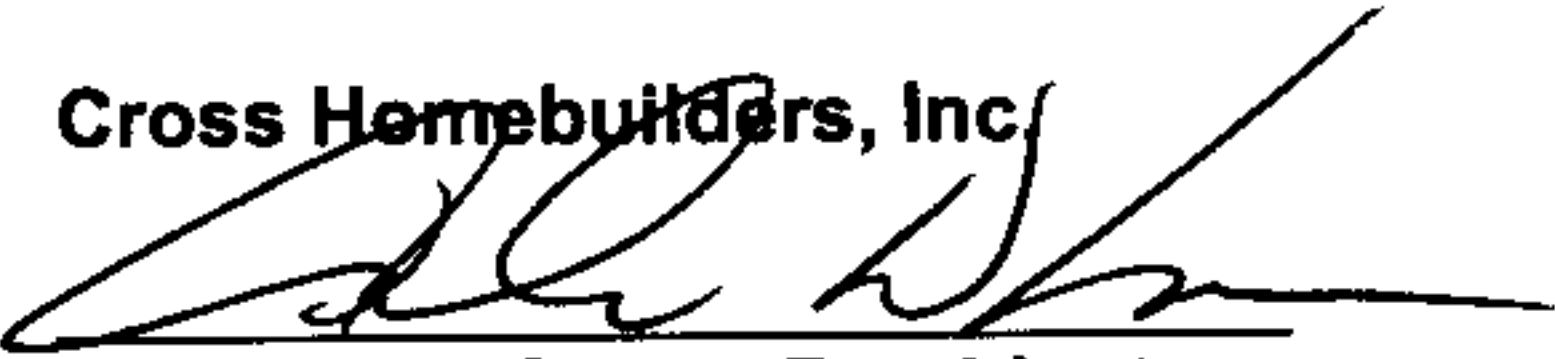

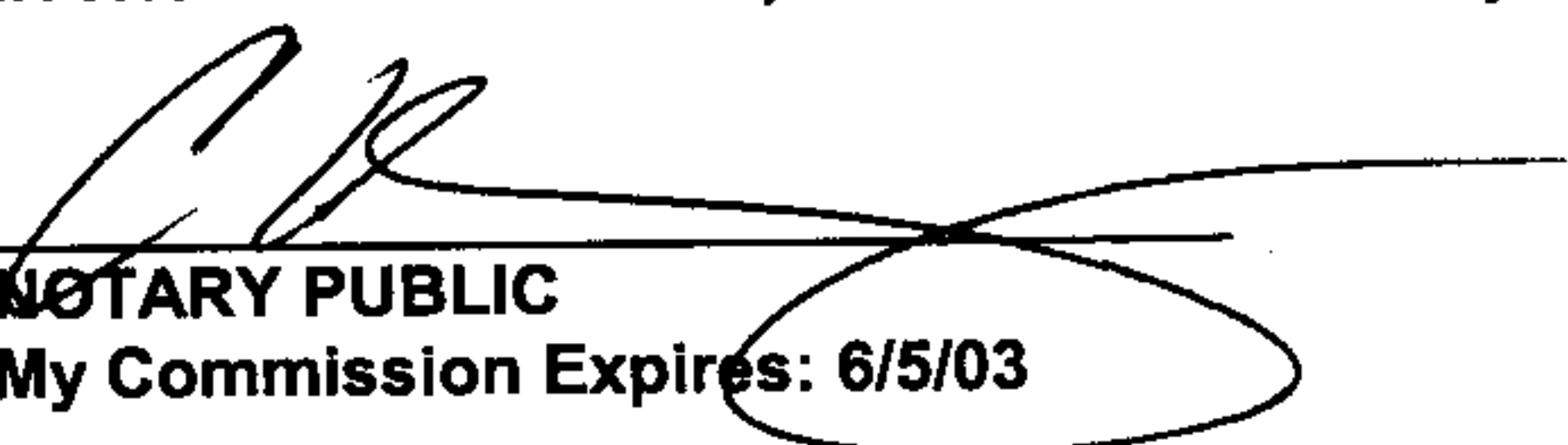
