KNOW ALL MEN BY THESE PRESENTS

That in consideration of One Dollar (\$1.00), and other good and valuable consideration, to the undersigned grantors, in hand paid by the GRANTEE herein, the receipt whereof is acknowledged, we,

(herein referred to as grantors), do grant, bargain, sell and convey unto
