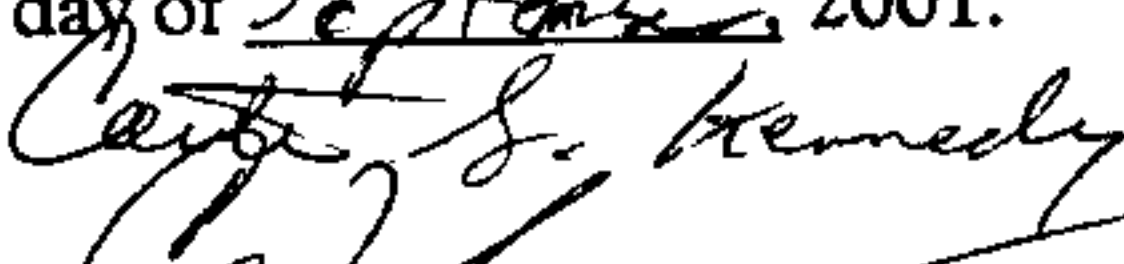
PARTIAL RELEASE OF LIEN

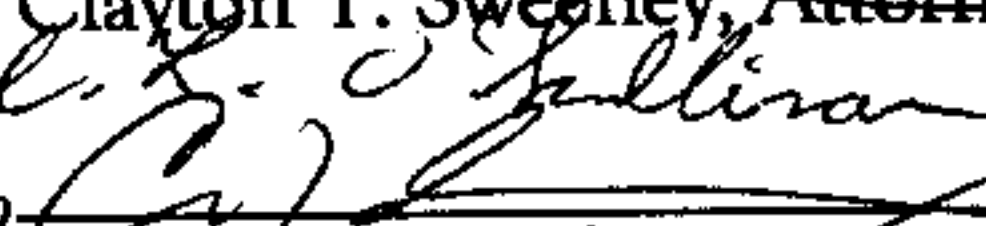

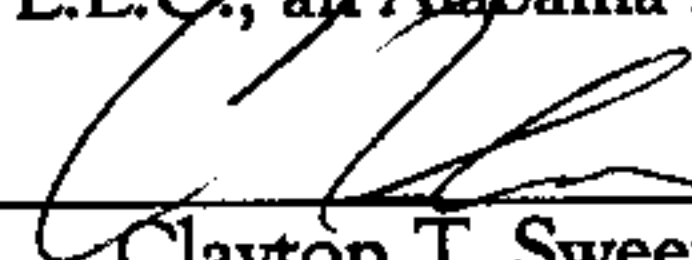
