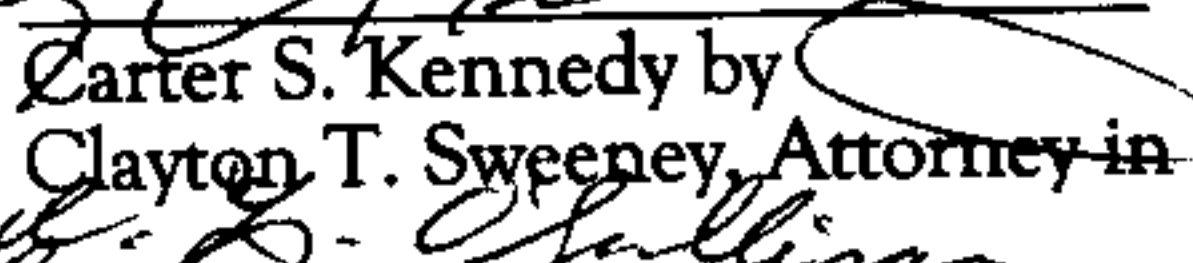
PARTIAL RELEASE OF LIEN

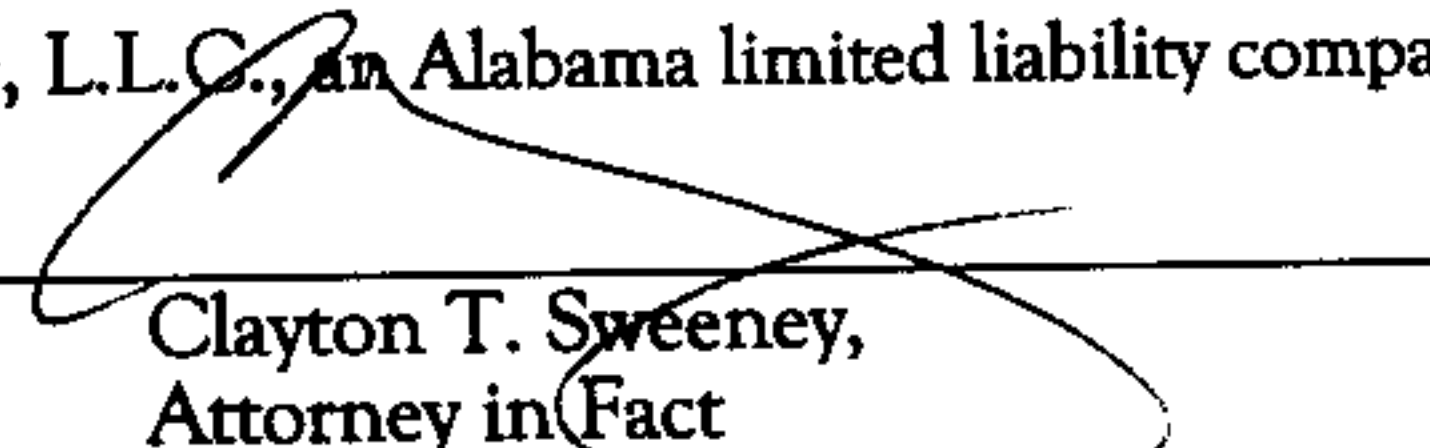
