**Know All Men by These Presents:** That in consideration of ONE HUNDRED EIGHTY SEVEN THOUSAND FIVE HUNDRED and 00/100 (\$187,500.00) DOLLARS to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt of which is acknowledged, we, KYLE R. HARGETT and YU-ING HARGETT, HUSBAND AND WIFE (herein referred to as GRANTORS) do grant, bargain, sell and convey unto RODNEY K. COX and JULIE R. COX, HUSBAND AND WIFE, (herein referred to as GRANTEES, as joint tenants, with right of survivorship, whether one or more) the following described real estate, situated in SHELBY County, Alabama, to-wit:

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said GRANTEES, his, her, or their heirs and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said GRANTEES, his, her, or their heirs and assigns forever, against the lawful claims of all persons.


