KNOW ALL MEN BY THESE PRESENTS, that in consideration of the need to privately maintain the common ingress/access easement serving the lands of the Lorino-Meadows Subdivision a map of which is recorded Map Book 27, Page 30 in the Probate Office of Shelby County, Alabama, Bernard S. Lorino, Bonnie S. Lorino, Donald M. Meadows and Angela L. Meadows, all the Owners of said subdivision, hereby agree as follows:

- 1) That maintenance of the ingress and egress easement as shown on the Lorino-Meadows Subdivision is the common responsibility of all Owners of said subdivision;
- 2) That individual Owners of said subdivision may make repairs and or improvements to said easement without prior approval of the rest of the Owners. However, if said individual or individuals fail to gain prior approval of the remaining Owners, the remaining Owners are in no way obligated to reimburse said individual/s for the repairs or improvements;
- 3) That any repair or improvement authorized by a majority vote of the Owners of the lots in said subdivision, with each lot having one vote, any cost of said improvements or repairs must be reimbursed by said lot Owners, each lot carrying one-third of the cost. Failure to so reimburse said repairs could result in legal action against the offending lot and its Owners. Reimbursements must be rendered within sixty days of completion of said repair or improvement;
- 4) That said easement for ingress and egress is both a benefit and a burden to each lot in said subdivision, and no lot Owner acting unilaterally can alter, destroy, convey, or impair the benefit of the easement, nor alleviate the burden of repair and maintenance of the easement, without the approval of all lot Owners.
