KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of Three Hundred Fifteen Thousand Nine Hundred and 00/100 Dollars (\$ 315,900.00) to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged, **R. JOHNSON HOMES, INC.** (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto **RICHARD E. WHEATON & TRELLIE M. WHEATON**, (herein referred to as "Grantee") as joint tenants with rights of survivorship, the following described real estate situated in Shelby County, Alabama, to wit:

Lot 23, according to the Survey of The Woodlands, Sector 1, as recorded in Map Book 27, page 63, in the Probate Office of Shelby County, Alabama.

Subject to all easements, restrictions, covenants, rights of way and covenants of record; taxes for 2002 subsequent years not yet due and payable.

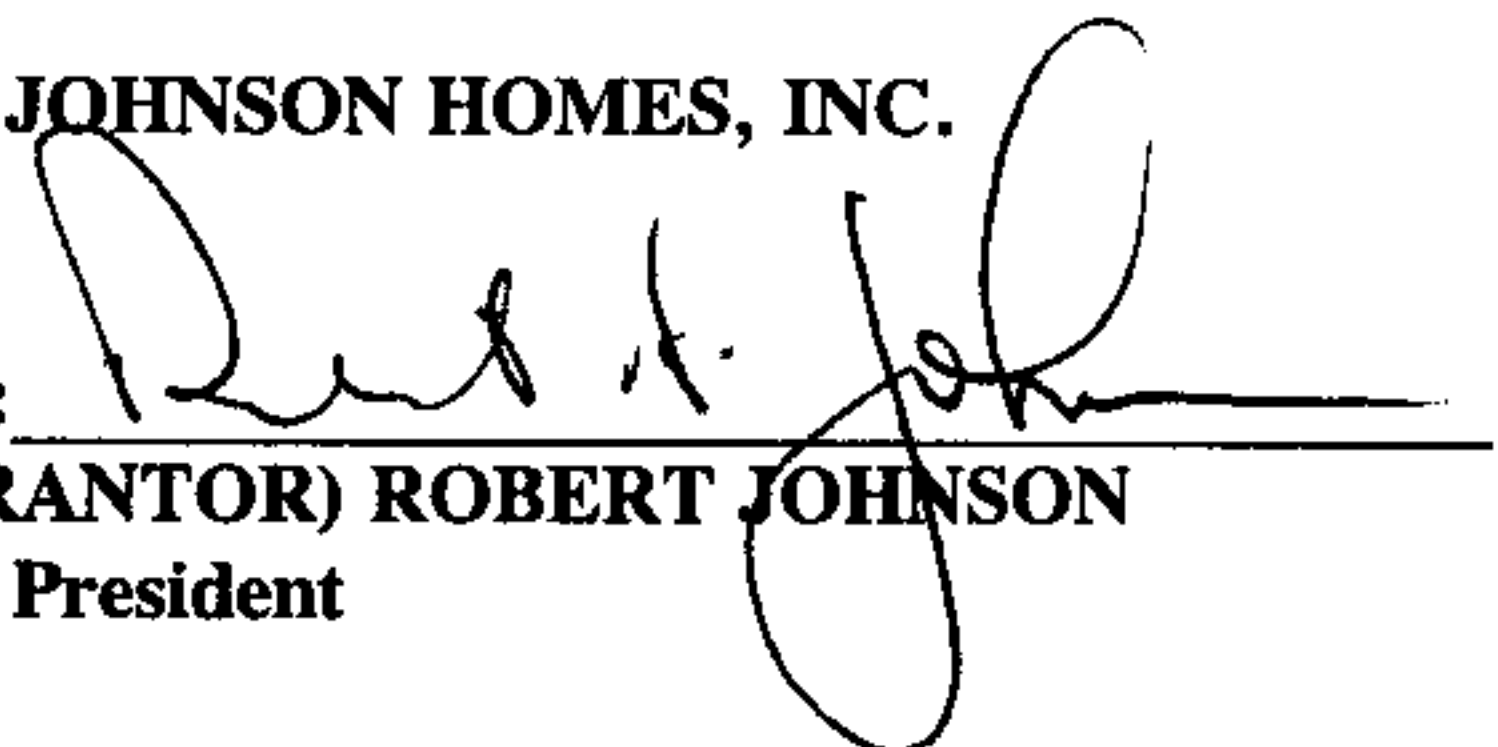
\$300,030.00 of the purchase price recited herein was paid from the proceeds of two mortgage loans closed simultaneously herewith.

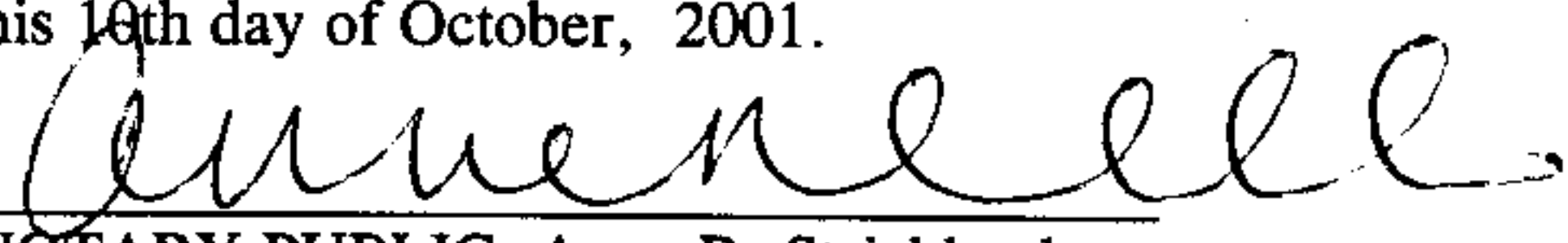
