KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of Two Hundred Twenty-Nine Thousand and No/100 Dollars (\$229,000.00) and other good and valuable consideration to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged **DARRELL F. BILBREY & WIFE, JODIE G. BILBREY**, (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto **BRIAN C. FEDERICO & WIFE, SARA B. FEDERICO**, (herein referred to as "Grantee"), as joint tenants with rights of survivorship, their interest in the following described real estate situated in **SHELBY** County, Alabama, to wit:

Lot 903, according to the Survey of Riverchase Country Club, 16th Addition, as recorded in Map Book 9, page 58, in the Probate Office of Shelby County, Alabama.

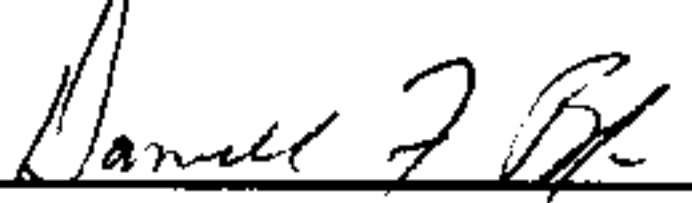
Subject to all easements, restrictions, covenants, rights of way of record; taxes for 2002 and subsequent years not yet due and payable.

\$183,200.00 of the purchase price was paid from a mortgage loan closed simultaneously herewith.

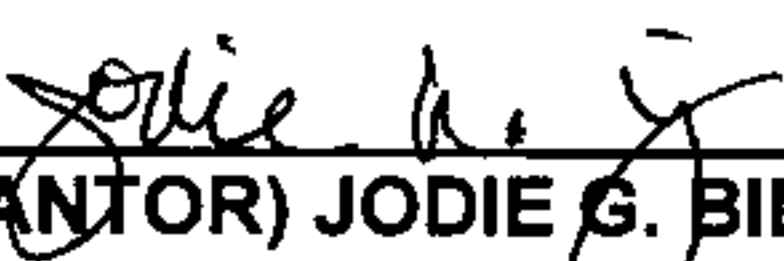
