\$259,400.00 of the purchase price received above was paid from a first purchase money mortgage loan closed simultaneously herewith.

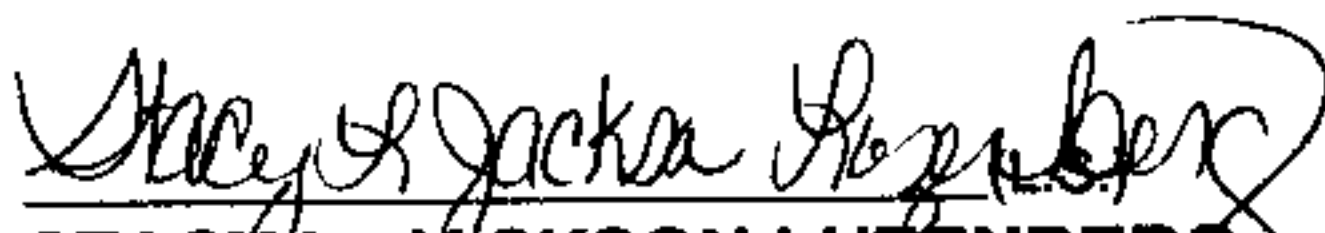
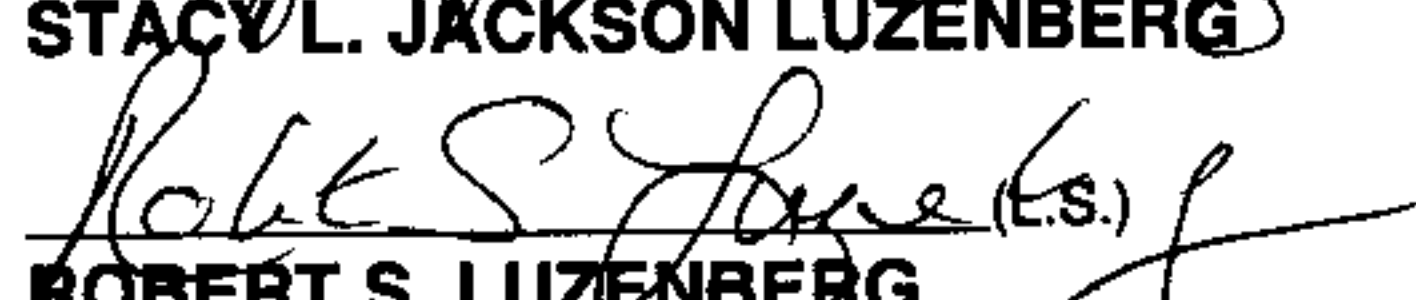
Stacy L. Jackson Luzenberg is one and the same as Stacy L. Jackson as stated on title.

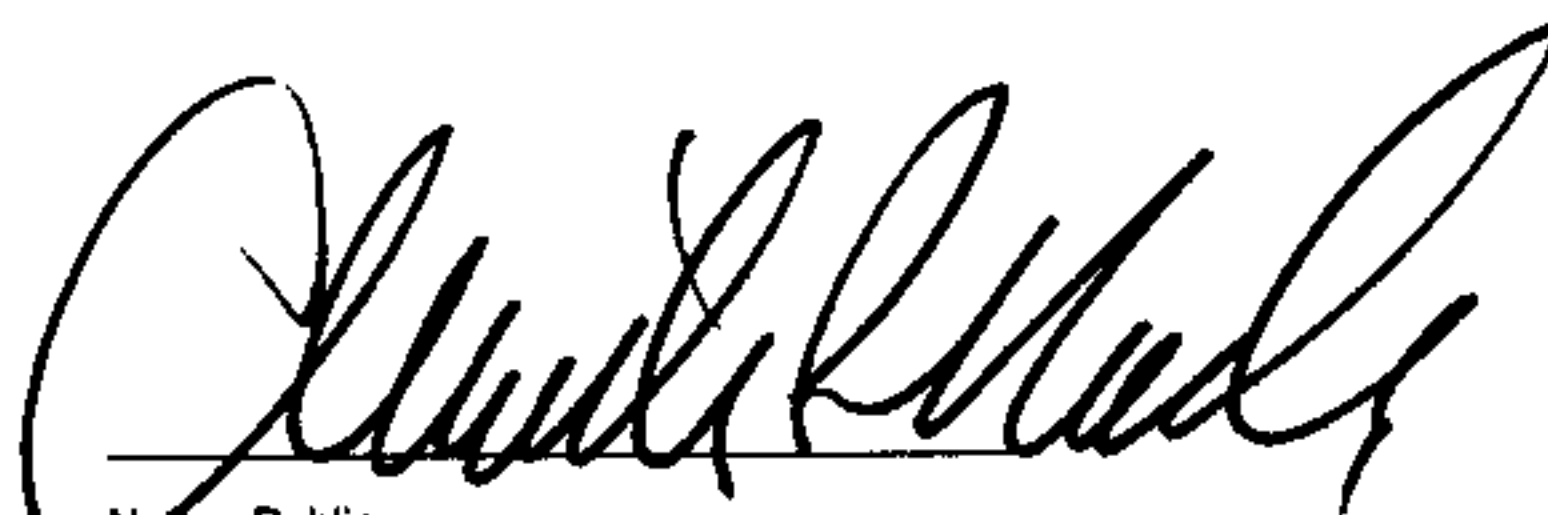
