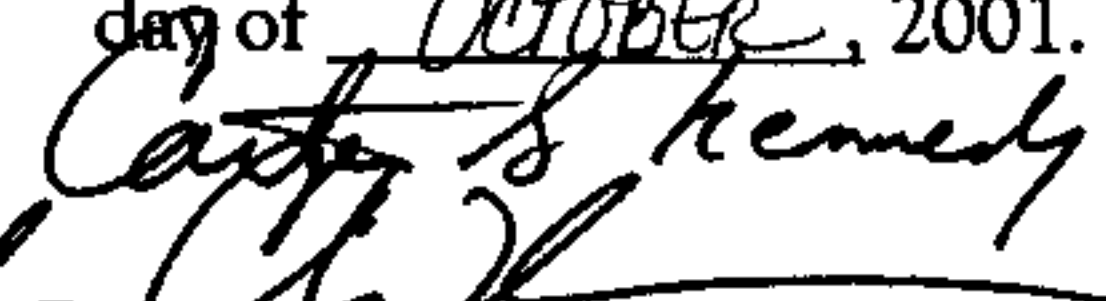
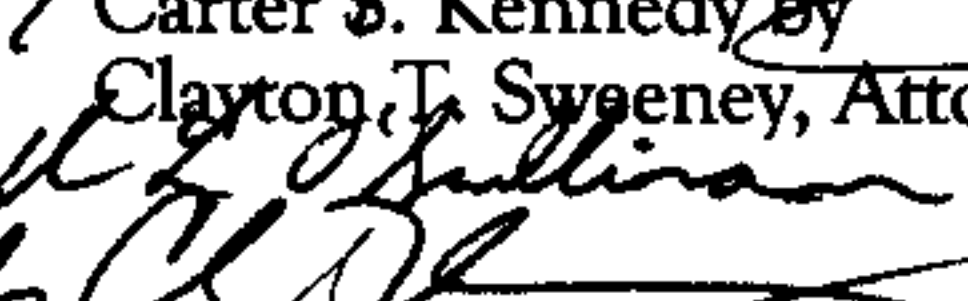
PARTIAL RELEASE OF LIEN

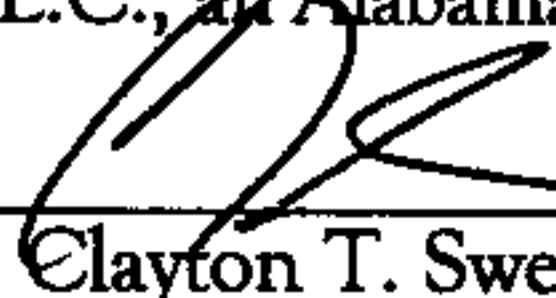
