- 2. Existing easements, restrictions, set back lines, limitations, if any, of record.

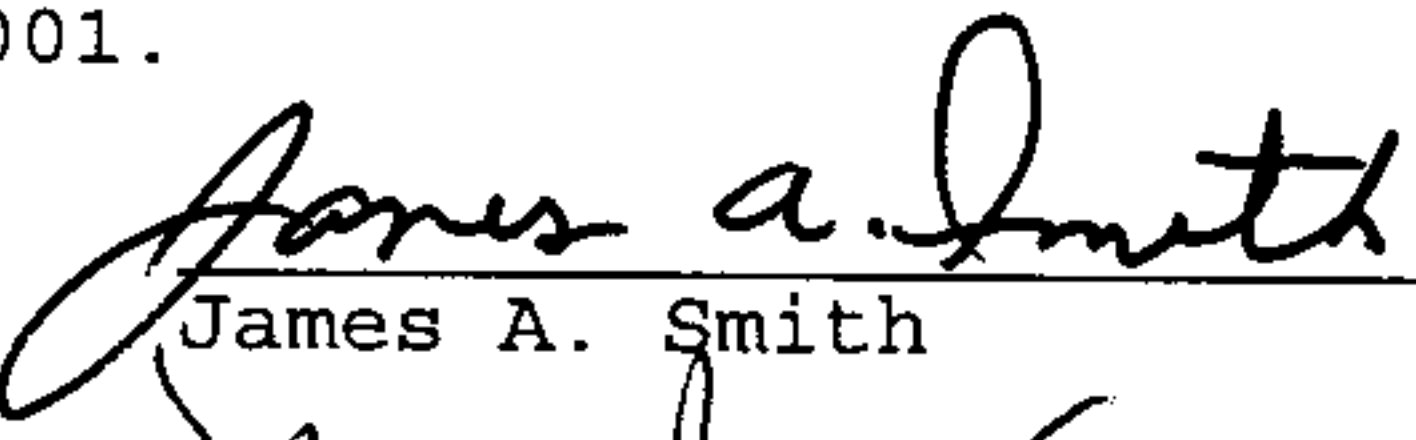
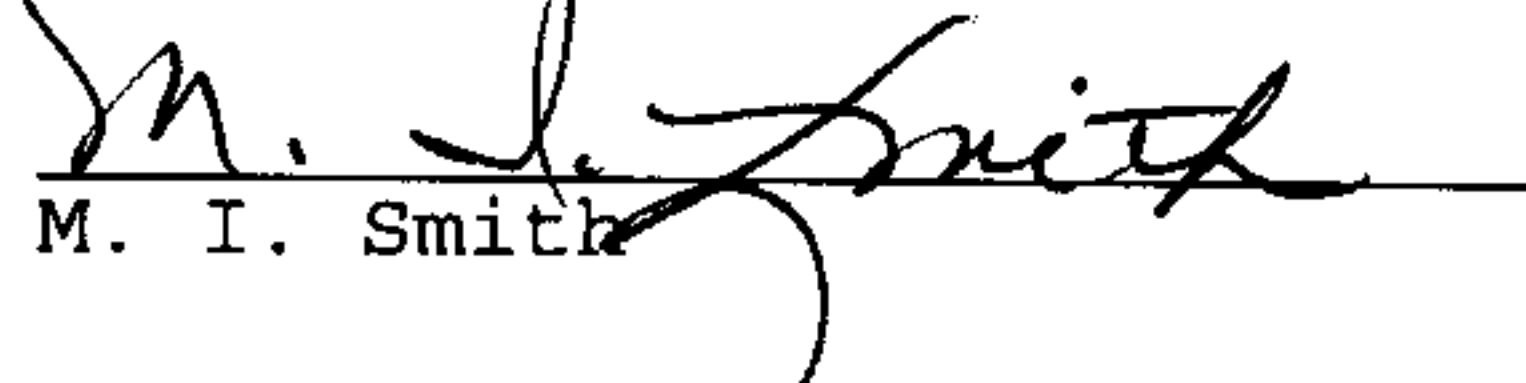

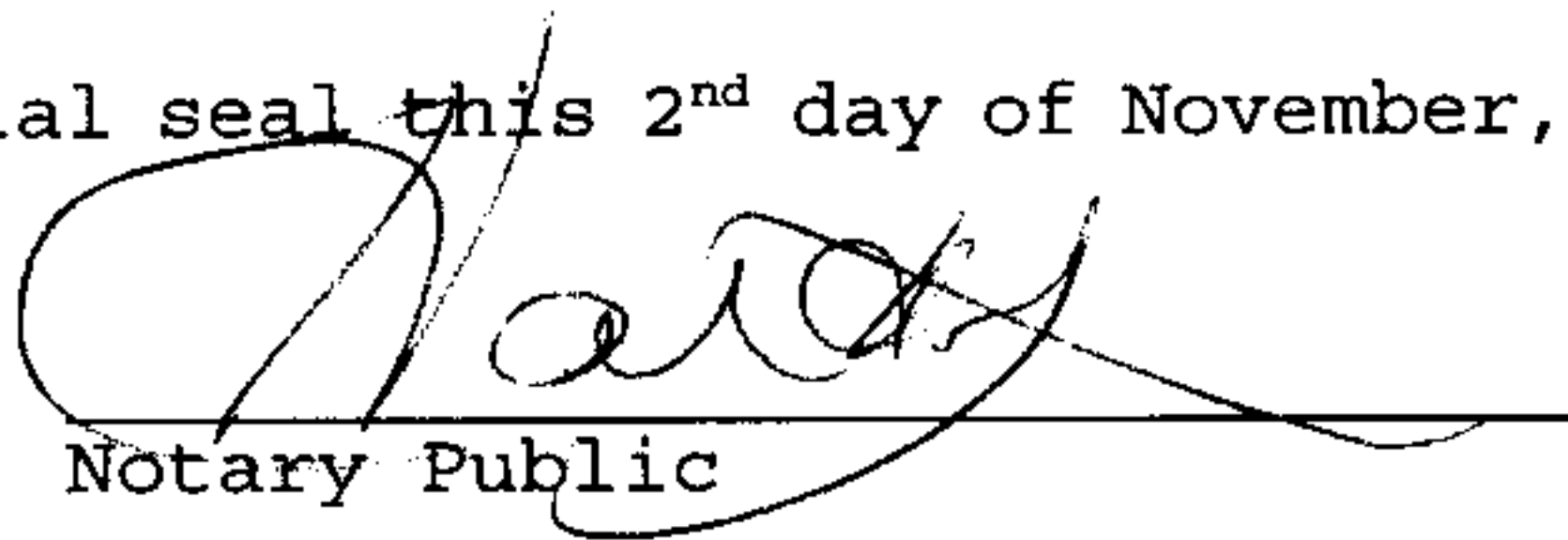
