

**ARTICLES OF INCORPORATION
OF

The undersigned, Andrea A. Lee, acting as incorporator of a corporation under the provisions of the Code of Alabama, Section 10-2B-2.01, et al., adopts the following Articles of Incorporation for the Corporation:

1. The name of the Corporation is **TYCO PROPERTIES, INC.**, and the Corporation is authorized to operate under that name or use any other trade name.

2. The Corporation is formed to conduct the sale and rental of real property and to transact any and all lawful business for which corporations may be incorporated under the laws of the State of Alabama.

3. The initial registered agent is Andrea A. Lee, and the initial registered office of the corporation is 2719 Goldmor Circle, Birmingham, Alabama 35244.

4. The authorized capital stock of the corporation is one thousand (1,000) shares having a par value of One and No/100 (\$1.00) Dollar per Share. The paid-in capital with which the corporation will begin business is One Thousand and No/100 (\$1,000.00) Dollars.
