JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

Smeltzer in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, the said Grantor does by these presents, grant, bargain, sell and convey unto Joseph P. Ardovino and wife Lori F. Ardovino (herein referred to as Grantees) as joint tenants with right of survivorship, the following described real estate, situated in SHELBY County, Alabama, to-wit:
