ORDER GRANTING PLAINTIFF'S MOTION FOR SUMMARY JUDGMENT

After hearing and due consideration of the issues presented by the plaintiff, AmSouth Bank ("AmSouth"), in its Motion for Summary Judgment against defendants Constantine N. Sfakianos ("Sfakianos") and Mark Randol ("Randol"), the Court finds that, pursuant to Ala. R. Civ. P. 56, summary judgment is due to be **GRANTED** as a matter of law as to each count of the Complaint against defendants Sfakianos and Randol. The Court further finds that AmSouth's complaint against defendants Birmingham Industrial Painting Company, Inc. ("BIPCO") and Paul T. Lane ("Lane") is due to be dismissed without prejudice.

In making this determination, the Court has relied on the following: (i) the pleadings in this action, including AmSouth's Verified Complaint; (ii) the Plaintiff's Motion for Summary Judgment; (iii) the Plaintiff's Memorandum in Support of its Motion for Summary Judgment; and (iv) the Affidavit of Lewis Compton, Jr. Accordingly, it is hereby

ORDERED, ADJUDGED and DECREED that judgment shall be entered against Sfakianos and Randol in the above-referenced matter in the amount of \$916,563.53, plus accrued

and accruing interest, plus \$19,208.03 in attorneys' fees. It is further ordered that AmSouth's complaint against defendants BIPCO and Lane is dismissed without prejudice.
