Know All Men by These Presents: That in consideration of **One hundred nine thousand nine hundred and no/100 (\$109,900.00)** to the undersigned grantor **Abana Enterprises, LLC**, a corporation, in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Abana Enterprises, LLC** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Bret L. Hooten and Delilah B. Hooten** (herein referred to as grantee, as joint tenants of survivorship whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:
