Know All Men by These Presents: That in consideration of Two hundred ninety eight thousand seven hundred and no/100 (\$298,700.00) to the undersigned grantor **Jimmy T. Subject to existing easements, restrictions, set-back lines, right of way, limitations, if any of record.

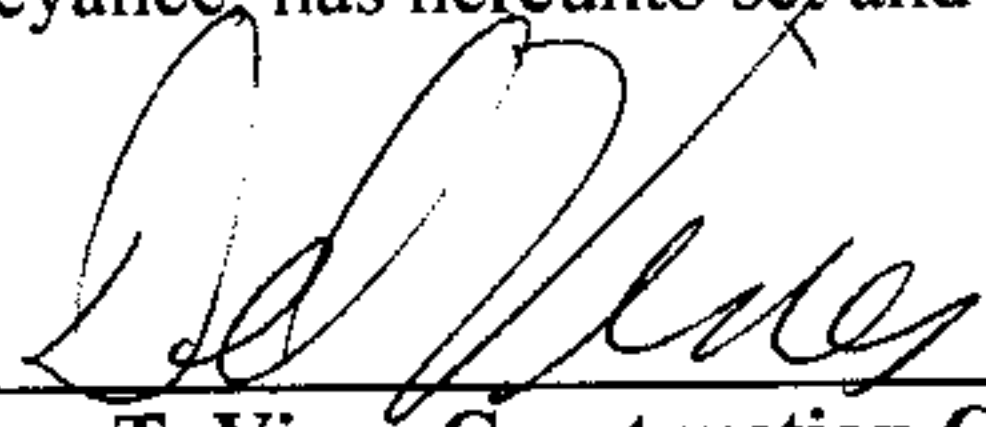
\$180,000.00 of the purchase price recited above was paid from mortgage loan closed simultaneously herewith.

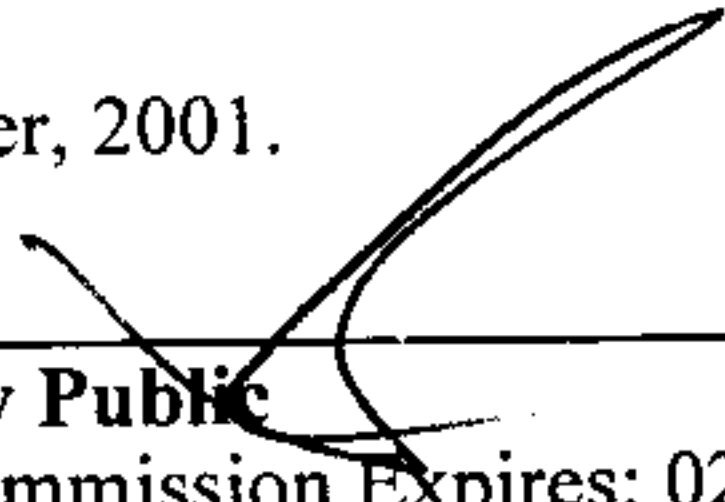
