KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of Two Hundred Fifty-Six Thousand and No/100 Dollars (\$256,000.00) to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged, DREAM HOUSE, L.L.C., (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto DAVID A. GOGGANS AND AMY M. GOGGANS (herein referred to as "Grantee"), as joint tenants with rights of survivorship, the following described real estate situated in SHELBY County, Alabama, to wit:

Lot 22, according to the Map and Survey of Oak Park Highlands, Sector 3, as recorded in Map Book 26, Page 136, in the Probate Office of Shelby County, Alabama.
