Know All Men by These Presents: That in consideration of **Ninety two thousand nine hundred and no/100 (\$92,900.00)** to the undersigned grantor **Builders Group, Inc.**, a corporation, in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Builders Group, Inc.** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Robert K. Johnson and Heather L. Johnson** (herein referred to as grantee, as joint tenants of survivorship whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:

Lot 175, according to the Survey of Camden Cove, Sector III, as recorded in Map Book 28, Page 3, in the Office of the Judge of Probate of Shelby County, Alabama.
