

THIS INDENTURE, made and entered into, this day of November, 2001, by and between the State of Alabama Department of Education, party of the first part, and the State of Alabama Department of Transportation, party of the second part, witnesseth that whereas it has been decided by the State of Alabama Department of Education not to use the hereinafter described lands for school purposes as set out in the deed conveying the same to the State Department of Education; and whereas the Board of Education of Shelby County has certified to Ed Richardson, as Superintendent of Education of the State of Alabama, that it is for the benefit of the public school interest of Shelby County, Thompson School, that said lands be sold.

AND WHEREAS, the State Superintendent of Education, with the approval of the Governor, has negotiated this sale under the provision of Section 16-20-8, Code of Alabama 1975, and whereas it has been certified by the State Superintendent of Education to the Governor, that this sale has been obtained and negotiated, and that all requirements of law with respect thereto have been complied with, and that such sale is concurred in by the Governor, as provided by Section 35-4-385, Code of Alabama 1975.

NOW THEREFORE, for and in consideration of the premises and of the sum of sixty-seven thousand twenty-five dollars (\$67,025.00) paid by the party of the second part, receipt of which is hereby acknowledged, I Don Siegelman, as Governor of the State of Alabama, and I Ed Richardson as Superintendent of Education of the State of Alabama, in pursuance of the authority conferred upon us by Section 16-20-8 and Section 35-4-285, Code of Alabama 1975, do hereby for the State and in its name grant, bargain, quit-claim and convey and by these presents have granted, bargained, quit-claimed and conveyed unto the party of the second part all of the right, title and interest of the State of Alabama in and to the following described property, to-wit:

A part of the SE¼ of the NW¼, and the NE¼ of the NW¼, Section 11, Township 21 South, Range 3 West, identified as Tract No. 36, Project No. SPTAA-458(1), Shelby County, Alabama, and being more fully described as follows:

Commence at the southwest corner of said NE¼ of the NW¼; thence easterly along the south line of said NE¼ of the NW¼ a distance of 957 feet, more or less, to the present southwest right of way line of Alabama State Road 119; thence northwesterly along said right of way line a distance of 455 feet, more or less, to a point that is 224.06 feet northwesterly of and at right angles to the centerline of Project No. STPAA-458(1) at Station 513+37.1 and the point of beginning of the property herein to be conveyed; thence continue northwesterly along the present southwest right of way line of Alabama State Road 119 a distance of 47 feet, more or less, to the present south right of way line of 14th Avenue; thence westerly along said right of way line a distance of 60 feet, more or less, to a point that is 21 feet southerly of and at right angles to the centerline of Relocated 14th Avenue at Station 16+49; thence southeasterly a distance of 80 feet, more or less, to the point of beginning. TO HAVE AND TO HOLD, to the said party of the second part together with all appurtenances, tenements and hereditaments thereunto belonging or in any wise appertaining, in fee simple forever.


