

**Articles of Amendment  
of  
Friends of The Alabaster Public Library, Inc.**


Pursuant to §10-2A-110, et seq., *Code of Alabama, 1975*, the **Friends of the Alabaster Public Library, Inc.**, an Alabama non-profit corporation incorporated in Shelby County, Alabama, on the 31 March, 1983, such *Articles of Incorporation* being recorded in Book 24, Page 246, in the Shelby County Judge of Probate's Office, hereby adopts the following amendment(s) to its *Articles of Incorporation*, to wit:

1. The name of the corporation is **Friends of the Alabaster Public Library, Inc.**
2. The Amendment(s) to the *Articles of Incorporation*, adopted by the Board of Directors pursuant to §10-2A-111, *Code of Alabama, 1975*, on the 16<sup>th</sup> Day of October, 2001, were as follows:

The name of the corporation shall be changed from **Friends of the Alabaster Public Library, Inc.**, to the new name of **Friends of the Albert L. Scott Library, a non-profit corporation.**

3. The number of Directors of the Board of Directors voting in favor of said amendment was unanimous, with none being voting against it.
4. Except as hereinabove otherwise expressly provided, the original *Articles of Incorporation* shall remain unchanged and in full force and effect.
