Know All Men by These Presents: That in consideration of One hundred ninety four thousand and no/100 (\$194,000.00) to the undersigned grantor **Freedom Properties, LLC**, a limited liability company, in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Freedom Properties, LLC** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Erik L. Olsen and Andrea G. Olsen** (herein referred to as grantee, as joint tenants of survivorship whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:

Lot 2, according to the Survey of Final Plat of Saddle Lake Farms, Second Addition, as recorded in Map Book 28, Page 76, in the Office of the Judge of Probate of Shelby County, Alabama.

Mineral and mining rights excepted

To Have and to Hold to the said grantee, as joint tenants, with right of survivorship, their heirs and assigns forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and, if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And I (we) do, for myself (ourselves) and for my (our) heirs, executors and administrators, covenant with said grantee, his, her or their heirs and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise stated above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will, and my (our) heirs, executors and administrators shall warrant and defend the same to the said grantee, his, her or their heirs and assigns forever, against the lawful claims of all persons.

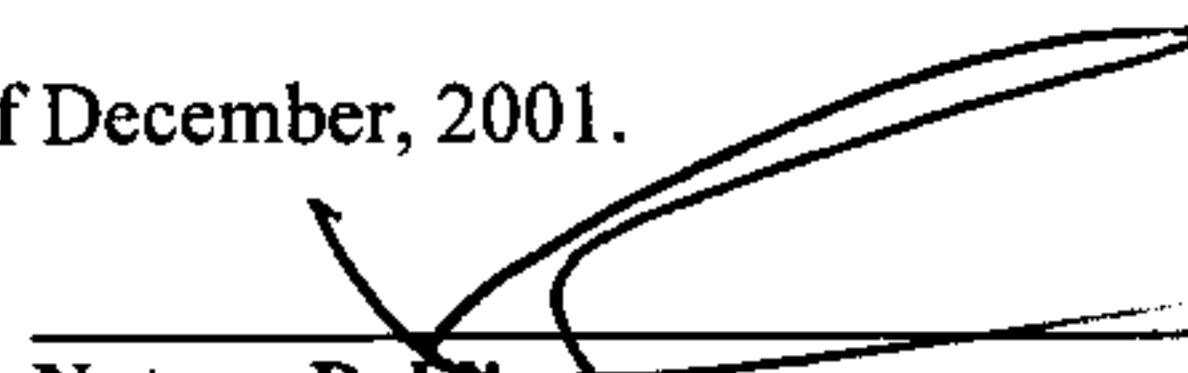
