TIME OF COMMENCEMENT

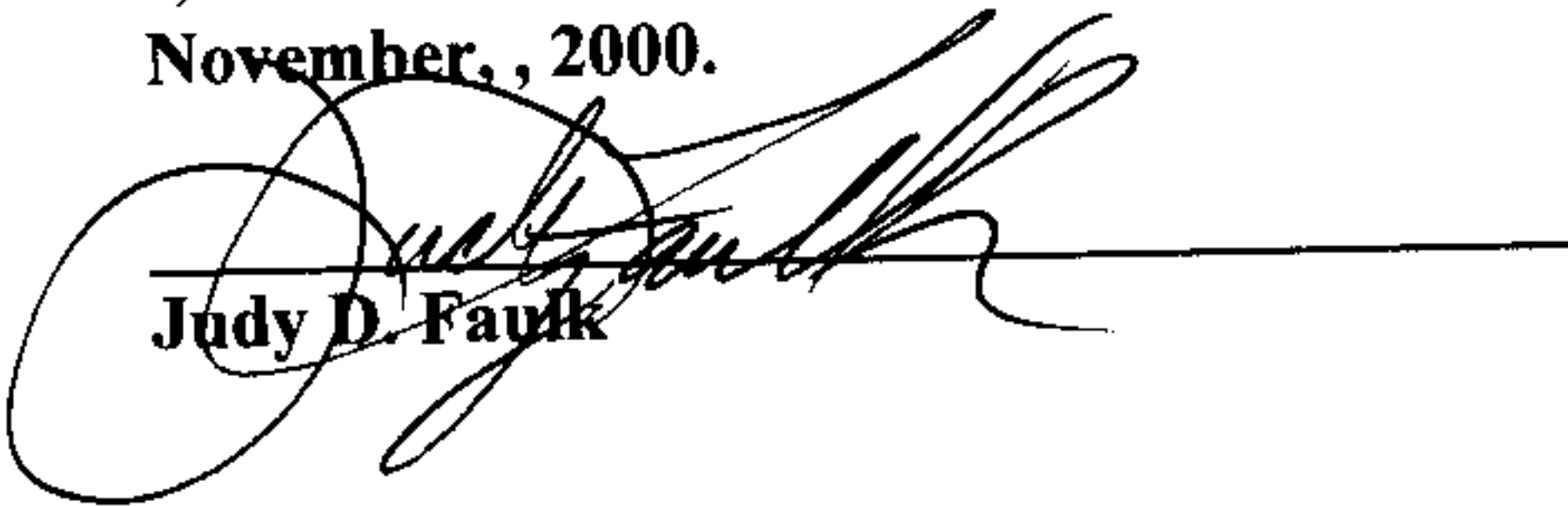
The time of the commencement of this corporation shall be November 01, 2000, which also shall bear the legally recorded date from the Judge of Probate, Shelby County, Alabama.
