Fuller and wife, Melissa D. Fuller**, hereinafter called "Grantor," does hereby GRANT, BARGAIN, SELL AND CONVEY unto **Brendon S. Fuller and Nicholas M. Fuller, single men**, hereinafter called "Grantee" in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in **Shelby County, Alabama**, to-wit:




