Pursuant to the provisions of the Alabama Non-Profit Corporation Act, the undersigned hereby adopts the following Articles of Incorporation.

Article I The name of the corporation is: EAA Chapter 825, Incorporated

Article II The duration of the corporation is perpetual.

Article III The corporation has been organized for the following purposes:

Promote, encourage and facilitate an environment that fosters safety and high standards in the design, construction, restoration and operation of all types of recreational aircraft.

Promote, encourage and facilitate educational and recreational aviation activities.
