KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of Two Hundred Fifty-Eight Thousand and No/100 Dollars (\$ 258,000.00) to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged, **SCOTCH BUILDING & DEVELOPMENT CO., INC.**, (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto **CHRISTOPHER A. KEITH & ANGELA J. KEITH**, (herein referred to as "Grantee") as joint tenants with rights of survivorship, the following described real estate situated in Shelby County, Alabama, to wit:

Lot 42, according to the Survey of The Cedars as recorded in Map Book 25, Page 134, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.

Subject to all easements, restrictions, covenants, rights of way and covenants of record; taxes for 2002 and subsequent years not yet due and payable.


\$ 258,000.00 of the purchase price recited herein was paid from the proceeds of a mortgage loan closed simultaneously herewith.
