- III. The county in which the corporation is to exercise its functions, or part of its functions, is Shelby County, Alabama.
- IV. A. The purposes for which the corporation is organized are religious, charitable, benevolent, educational, or any other lawful activity for which corporations may be organized under §§ 10-4-20 et seq., Code of Alabama 1975, as amended, including the following specific purposes:
 - 1. To provide an environment where people can learn to love God, care for others, discover Jesus, and identify with His believers by fulfilling the Great Commandment (Matthew 22:36-40) and the Great Commission (Matthew 28:18-20).
 - 2. To worship to participate in public worship services together and to maintain personal daily devotions.
 - To witness to share the good news of Jesus Christ with as many people as possible in our community and throughout the world.
 - 4. To educate to help members develop toward full Christian maturity and train them for effective ministry, and to promote personal, spiritual growth and discipleship through Bible teaching.
 - 5. To minister and serve to serve unselfishly, in Jesus' name meeting the physical, emotional, and spiritual needs of those in this Church, community, and in the world.
 - 6. To fellowship to encourage, support and pray for each other as members of the family of God, and to share our lives together.
- B. Notwithstanding any of the powers or purposes of the corporation contained in this Certificate of Incorporation or granted by law, the purposes for which the corporation is organized are exclusively religious, charitable, and educational within the meaning of § 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
